Item # 7 Matt Kiecker discussion on a proposed change to the certified survey map for property in the NE ¼ of the SE ¼ of Sec. 23. (see copy attached) A motion by E.Downing and a second by C.Bauer to approve the proposed change as submitted. Motion carried unanimously.

Item # 8 Mecko Manufacturing, discussion and action for a proposed sign at 8455 CTH. CR. This is a non-lighted sign placed on the building. (see copy attached). A motion by J.Ney and a second by E.Downing to approve the sign permit request as submitted. Motion carried unanimously.

Item # 9 Rodney Fischer, a public hearing for a 2.2 acre of land for a zone change from A-3 to A-2.
